29862759	In JET UI, tabs and attributes marked as hidden were visible until page load completed.	Hidden tabs and attributes are not displayed at all.		
29661882	Attributes with names similar to system attributes and used as input to BML scripts did not update when the BML ran.	Attributes with names similar to system attributes and used as input to BML scripts update appropriately when the BML runs.		
29933274	Commerce Boolean attributes were unnecessarily able to be marked as Required.	When creating or modifying a Commerce Boolean attribute, the Required checkbox option is no longer available.		
29961822	System-generated error message text was allowed to be overridden by empty message text causing the error to not display and the Transaction to be able to be saved.	System checks for error rather than the translated value. Therefore, the error displays and prevents the Transaction from being saved.

- "Major update" = Update 19D
- "Minor update" = Update 19D Patch 1

Beginning in 19D, migration packages from 19A and forward can be uploaded to the latest site version.
